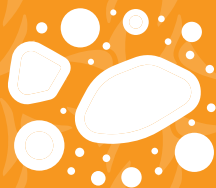

DIRECTIONS FOR USE

General directions

Prior to use, read all the directions on this label and on the labels of any other products being used with this product. The manufacturer's label for specific usage and restrictions of other products has precedence over directions for use referred to on the PERMEATOR label. Test for compatibility prior to mixing and application with other chemicals. Always test new tank-mix combinations before widespread use.

Mixing

To ensure thorough mixing, recirculate mini tanks and bulk tanks or shake containers before using. Pre-rinse all tanks, spray lines or containers thoroughly before adding PERMEATOR as PERMEATOR contains surfactants. PERMEATOR should not be added to tanks, spray lines, or containers which may contain additional surfactant adjuvants. Coatings on inner tank and spray lines from previous chemicals sprayed, may be dissolved by PERMEATOR. When applying as a soil spray, add water to the spray tank until nearly full, then add PERMEATOR and agitate gently to ensure mixing with minimal foam generation.

Application and rates

Early spring applications are most effective followed by repeat applications as needed. Apply PERMEATOR at 10 L/ha through furrow, flood, micro-jet, sprinkler jet and other irrigation systems. It can also be applied in conjunction with most types of liquid fertilizer. In addition, it can be applied as a soil spray. When metering PERMEATOR directly into an irrigation system by means of a metering injection pump or suction regulated line, do not connect to an irrigation system used for chemical applications or directly to a public water system without a back siphon prevention system in place. Always connect to such systems in accordance with local and/or state regulations.

Storage and disposal

KEEP OUT OF REACH OF CHILDREN.

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight.

This container can be recycled if it is clean, dry, free of visible residues and has the drumMUSTER logo visible. Triple-rinse container for disposal. Dispose of rinsate by adding it to the spray tank. Do not dispose of undiluted chemical on site. Wash outside of the container and the cap. Store cleaned container chemical on site. Store cleaned container in a sheltered place with cap removed. It will then be acceptable for recycling at any drumMUSTER collection or similar container management program site. The cap should not be replaced, but may be taken separately.
